

Discovery (Pty) Ltd (“Discovery”): Ed Sheeran, social media competition terms and conditions (January 2019).

The following terms and conditions relate to the Discovery Retro Run– #10YearChallenge social media competition (“Competition”). By taking part in this Competition, you agree to accept these terms and conditions.

The Competition and who qualifies:

1. This Competition is open to persons who live in South Africa.
2. Children under the age of fourteen must be accompanied by a parent or legal guardian and no children under the age of three are allowed to attend the Event.
3. All information relating to this Competition and published on any promotional material will form part of these terms and conditions.
4. The Competition starts on 25 January 2019 and ends at 23:59 on 31 January 2019. Any entries outside of these dates will not be eligible for entry into the prize draws.
